Meet the Presenter




David L. Corwin, MD Dr. Corwin is a Professor of Pediatrics and Director of Forensic Services in the Pediatrics Department at the University of Utah. He moved to Utah in 1999 to become Medical Director of Primary Children's Child Protection Team that was later renamed the "Center for Safe and Healthy Families." In 2002, the Pediatrics Division of Child Protection and Family Health was born, and he became its first Chief serving in that role until 2012. In 2012, Dr. Corwin became the Pediatrics Department's Director of Forensic Services. He is a Past President of the American Professional Society on the Abuse of Children (APSAC), the Academy on Violence and Abuse (AVA) and the California Professional Society on the Abuse of Children (CAPSAC). Since 1986, Dr. Corwin helped to found five professional societies addressing child maltreatment and interpersonal violence including: CAPSAC and APSAC founded in 1986, the Ray E. Helfer Society in 1999, the AVA which formed in 2004, and the National Health Collaborative on Violence and Abuse (NHCVA) that emerged from the **American Medical Association's National Advisory Council on** Violence and Abuse in 2009. He joined the American Academy of Child and Adolescent Psychiatry's Child Abuse and Neglect Committee at its origin in 1992 and chaired it from 2001 to 2007. While Dr. Corwin was its Chair, the Committee became the Child Maltreatment and Violence Committee to include children's exposure to domestic violence, and he continues as its longest serving member. He is the author or co-author of numerous articles, commentaries, and chapters, addressing child sexual abuse, custody disputes, childhood trauma, childhood abuse memory, professional practice addressing child sexual abuse, and the Adverse Childhood Experiences Study (ACES). Dr. Corwin produced several videos addressing childhood trauma, the ACE Study, an eleven-part series featuring video clips to illustrate the USA's child maltreatment field evolution over the past 70+ years posted on the APSAC website, and a film celebrating CAPSAC's and APSAC's founding in 1986. Dr. Corwin has given over 300 presentations around the world. Dr. Corwin consults, evaluates, and testifies in child sexual abuse and childhood trauma cases throughout the USA. He is a founding member of the National Initiative to End Corporal Punishment

(NIECP) and co-chairs its Policy Committee. He also serves on the

Prevent Child Abuse Utah Board and other Utah advisory councils.

He was on the Committee on Child Abuse and Neglect for the American Academy of Pediatrics, is on the International Advisory Panel for the National Center on Shaken Baby Syndrome, is the former President and Board Chair of the Academy on Violence and Abuse, served as Vice-chair of the US Advisory Board on Child Abuse and Neglect, and the boards of APSAC, and Prevent Child Abuse America. Randy has served on state child death review committees in Iowa, Georgia and Florida. He was chair of the Committee on Child Abuse for the Georgia and Iowa chapters of the American Academy of Pediatrics and currently chairs the Committee in Florida. Randy has authored numerous articles, chapters, and books, and lectures frequently in the US and other countries.
